The 2018 NICOA Conference on Aging in Indian Country was held at the Pechanga Resort and Casino in Temecula, California on September 10-13, 2018. ## Road to the 2020 Census



His generous spirit impacted so many people here in California. Numerous Native communities in California benefited from his vast economic development knowledge, expertise and passion. Many will remember Dave for his commitment to protecting sacred sites and cultural resources through his work with the [California Native American Heritage Commission](#). In his younger years, he was involved in the civil rights movement, primarily in New York and Alabama. Dave will always be remembered for his generosity, kindness, intelligence, passion, and great sense of humor. He will be greatly missed.
